WHAT DOES TRUE PARTNERS CONSULTING LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal Law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depends on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> • Social Security Number and Income • Account Balance and Payment • Credit History and Credit Scores
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons True Partners Consulting chooses to share; and whether you can limit this sharing.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ Our affiliates include TPC 2.0, True Partners Consulting Holdings, True Partners Consulting Archive Services, and True Partners Consulting LLC.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ Nonaffiliates we share with can include other financial, legal, and tax service providers.

Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ▪ Our joint marketing partners may include members of the True Partners' network of service providers.

Other important information

California Residents: Under California law, we will not share information we collect about you with companies outside of True Partners Consulting, unless the law allows. For example, we may share information with your consent to other service providers. We limit sharing among our companies to the extent required by California law.

Vermont Residents: Under Vermont law, we will not share information we collect about you with companies outside of our corporate family, unless the law allows. For example, we may share information with your consent to other service providers or joint marketing partners.
